If they pass, VCH awardees must renew their certification every three years and prove at least 30 hours of sanctioned horticulture focused training within that timeframe.

The VCH designation offers many benefits to businesses and consumers as well. Consumers are assured they will receive professional services from a capable associate and the confidence that any business employing a VCH certified employee is a credible source for their nursery or landscaping needs. Additionally, VCH designations provide businesses a standard for evaluating potential and current employees.
